### 2. For Students availing Institute Scholarship:

- Those students admitted in BE/D2D in the year 2017-18, 2018-19 & 2019-20 and availed 50% and 25% Scholarship category, are required to pay balance fees on or before \* 'Fee Collection End Date'. Those students who availed 100%, 50% and 25% scholarship category and have not maintained 75% or above attendance in his/her previous semesters are required to pay fees i.e. Rs. 37000/- on or before \* 'Fee Collection End Date'. Fees will be accepted with late fee of Rs. 25/- per day after \* 'Fee Collection End Date'. If there is any query, please contact Mr. Dipak Patel at Admin Office.
- In case of non-fulfillment of condition no. 8 (No Backlog) & 9 (SPI/CPI not less than 6.50) of the terms and conditions of 'Meritorious Student Scholarship', (as signed by the students & parents to avail the scholarship), the unearned amount of scholarship shall be paid by the student within (i) 15 days of declaration of result by GTU, if the student is not opting for rechecking / reassessment or if as per the prevailing rules of rechecking / reassessment, there are no possibilities of clearing all the backlogs OR (ii) 7 days of declaration of rechecking / reassessment result by GTU or GTU Exam Form Fill up Date, whichever is earlier, if the student is opting for rechecking / reassessment.

### 3. Fee should be payable as per the following:

- Fee will be accepted with late fee of Rs. 25/- per day after \* 'Fee Collection End Date' at college Admin Office only.
- Any student who has admission in the year of 2010 or before & 2011, have to pay tuition fee of Rs. 18000/- & Rs. 23000 per semester respectively at Admin office before \* 'Fee Collection End Date'. Thereafter fees will have to be paid with late fee of Rs. 25/- per day.
